

# The Waffle Club of the New Mexico Institute of Mining and Technology

We the People of the Waffle Club, in Order to form a more perfect Waffle, establish Crispyness, ensure a Golden Color, provide for the addition of Syrup, promote the general Nutrition, and secure the Blessings of Batter to ourselves and our Posterity, do ordain and establish this Constitution for the Waffle Club of the New Mexico Institute of Mining and Technology.

## **Article I Name**

SECTION 1. FULL NAME The full name of the club shall be long and difficult to pronounce.

SECTION 2. COMMON NAME The club shall be referred to in casual situations as the Waffle Club, in more formal situations as the Waffle Society, and in extreme situations as the Waffle Union.

SECTION 3. DEMONYM Club members should be referred to as "Wafflites" or "Wafflers," and never as "Waffleers." "Those waffle people" is also acceptable, and in many cases preferred.

## **Article II Purpose**

SECTION 1. WAFFLES The purpose of the Waffle Club shall be Waffles.

SECTION 2. RAVES The purpose of the Waffle Club shall sometimes be Raves.

SECTION 3. WHATEVER The purpose of the Waffle Club shall always be Whatever.

## **Article III Membership**

SECTION 1. ELIGIBILITY All students, faculty, and staff of the New Mexico Institute of Mining and Technology are eligible for membership.

Random passersby are also eligible.

Including animals and inanimate objects blown by the wind.

SECTION 2. CLASSIFICATION Members shall be classified in to two groups, arbitrarily and without explanation.

The first group shall be the Red Team, and the second group shall be the Blue Team. The teams should not trust members of the other, as the team that you are not on is infamous for treachery and ill intent. The two teams shall each raise a small but well armed defense force, and should work to secure all available resources in preperation for inevitable attack by the other team, because they are treacherous.

## **Article IV Officers**

The Waffle Club shall have the following officers:

SECTION 1. THE WAFFLEMEISTER The Wafflemeister shall be in charge of all Waffle Club operations.

SECTION 2. THE CHIEF FINANCIAL WAFFLECER The Chief Financial Wafflecer shall exist.

SECTION 3. THE VICE PRESIDENT OF ATTENDING MANDATORY CLUB MEETINGS The Vice President of Attending Mandatory Club Meetings shall attend mandatory club meetings.

SECTION 4. DEPUTY WAFFLEMEISTERS One or more Deputy Wafflemeisters shall assist the Wafflemeister in whatever ways necessary, including the fetching of coffee and the *fixing of problems*.

SECTION 5. HONORARY OFFICERS One or more honorary officers will hold honorary titles and hopefully not make fools of themselves.

SECTION 6. THE ADVISORY BOARD A Waffle Iron Advisory Board shall be convened from time to time. The Board should incorporate the Wafflemeister, or another officer, or anyone else who is around.

SECTION 7. SELECTION Officers shall be appointed arbitrarily by the Wafflemeister.

SECTION 8. SUCCESSION Should the Wafflemeister die, graduate, or in any way be compromised, someone else shall assume control of the Waffle Club.

SECTION 9. SOMEONE ELSE Someone Else shall be understood to literally mean any random person. Should multiple people attempt to take the role of Someone Else, only one person may prevail. The Waffle Club does not condone violence, but also does not condemn it.

#### **Article V Meetingss**

SECTION 1. TIMES The Waffle Club shall meet whenever, but particularly on Thursday at 10:30.

SECTION 2. PLACES The Waffle Club shall meet wherever, but particularly at La Raj.

SECTION 3. NOTIFICATIONS Club members may be given advanced notice of meetings, but they also may not be.

#### **Article VI Expenditure of Funds**

The Wafflemeister shall expend funds.

#### **Article VII Faculty Advisor**

The Waffle Club shall select a faculty advisor, who will sign the club charter in the correct location and then do whatever.

#### **Article VIII Miscellaneous**

SECTION 2. FUNDRAISING Funds may be raised at any time, without warning or consent.

SECTION 3. FLANNERY Flannery Kate Green Leaf O'Brian Norton Cormier shall not have fun.
